The 2023/24 year we haven't been able to commit to as many events due to time constraints of all committee members, but we have delivered some fantastic events and will finish the year with our annual Summer Fair. The workload is far too great for 3 committee members alone to maintain the level of fundraising so moving forwards the recommendation is to have more committee members to share the effort, or do less events with secured match funding to enhance profitability.

We feel its time a new committee takes over to give the PTFA some fresh energy and direction and we look forward to hearing about all the fab events in 2024/25 and beyond.

## Headteacher Report (Helen McKenna)

Helen McKenna thanked the committee acknowledging how difficult it can be to keep activities going and the resilience needed. She reported that it was great to know that school can call on the PTFA and that they are there to support with funding initiatives. She encourages a new intake for the PTFA for the end of this year and into next year, and will welcome a fresh look and new ideas building on the fantastic work done over the last few years. The school is grateful for all the funding which has been very well used, mostly pupil wellbeing resources and outdoor equipment this year. In addition, the legacy of the playground markings will be with the school for children of years to come. This work would have otherwise been unaffordable.

The support of the PTFA financially, as well as the fun and the regular bringing together of the school community, is very much needed, and more than ever with the current financial difficulties for schools and families.
